By signing this accreditation form, I confirm that I am aware of all potential hazards and risks associated with motorsport events and working within a motorsport environment. Therefore, I undertake to immediately and unconditionally comply with all regulations and instructions communicated to me in writing, verbally, or by any other means (e.g. hand signals). Such instructions may be issued by event officials, the race jury, security personnel, the police, or other authorized personnel acting in an official capacity. Furthermore, I undertake to act in a manner that does not endanger, damage, or interfere with the event and to comply with the safety regulations below.

- I will not enter the track or route (= racing line), designated safety zones (= safety distance), and/or prohibited areas marked within the circuit area or route. I understand that I am acting entirely at my own risk whenever I am outside the designated spectator areas, even when I am in areas where media access has been granted by the organizer (for example, the paddock, pit lane, or designated locations for photographers, videographers, or journalists). The media circuit map identifies the areas reserved for accredited photographers. To obtain a photography permit, photographers must attend the mandatory briefing at the press office located in the paddock.
- While working within the circuit area and moving around the event venue, I agree to wear the mandatory media vest and media pass at all times. A refundable deposit of €20 will be charged for the media vest. The deposit will be refunded upon return of the vest. The media vest must be returned to the press centre when leaving the event, no later than Sunday, 5 July 2026, at 18:00.
- I agree not to make any claims for compensation arising from accidents, injuries, or damage to my property while outside designated spectator areas, unless such damage has been caused intentionally or through gross negligence, against: 1) the event organizer, 2) officials of the event organizer, 3) the race jury, 4) motorcycle owners participating in the event, 5) competitors, or 6) teams participating in the event, while they are organizing, preparing for, or participating in activities such as start practice, practice sessions, qualifying sessions, races, or other activities directly related to the event. I understand that any compensation claims will be handled in accordance with applicable liability and damages legislation.
- The use of drones during the event requires prior filming permission and is only permitted with the approval of the Clerk of the Course. The drone must be operated safely and remain

under the operator's control at all times. It must not fly directly above spectators or competitors and must not create danger, disruption, or interference for competitors, officials, spectators, or the organization of the event. Drone operators must possess a valid registration certificate issued by Traficom.

- For safety reasons, media vests intended for photographers are reserved exclusively for photographers producing editorial media content and for photographers contracted by Imatran Moottorikerho. Photography from public spectator areas is permitted without a photography permit.

Applicants seeking a media pass or photography permit must complete this accreditation form and submit it to the Press Officer at media@imatranajo.fi (Imatran Moottorikerho ry) no later than 25 June 2026. Late or incomplete applications will not be considered. Notification of accreditation approval or rejection will be sent as soon as the application has been received and processed.

Failure to comply with these rules, instructions, or any directives issued by the event organizer will result in the immediate withdrawal of accreditation.
